

CA training contract

A training contract is a three-year learnership contract with a registered training office. You may apply for a training contract at any time during your studies. If you are successful, your learnership will start the year after you complete your honours degree or obtain your Certificate in the Theory of Accounting (CTA) or equivalent qualification. You can also choose the Tax Elective skills area.

SAIPA learnership

The SAIPA learnership is aimed at candidates who want to qualify as a professional accountant. It is run in partnership with the South African Institute of Professional Accountants (SAIPA). Students on this three-year programme serve their articles over three years in our Assurance line of service, specialising in accounting. They build strong relationships and gain a thorough understanding of their clients' businesses. They are able to offer advice that is closely tailored to each client's business and needs, addressing challenges while at the same time anticipating and creating opportunities for success.

Auditing Support Services Africa

The Assurance Service Delivery Centre provides audit support services to audit teams across Africa on a remote basis. They perform general auditing functions according to PwC methodology. The growth of the SDC in Port Elizabeth is a PwC strategic initiative, providing career opportunities to non-CA stream graduates.

This training programme takes three years to complete. Individuals who want to work in forensics are required to be part of the Association of Certified Fraud Examiners (ACFE).


