Cancellation and refund policy

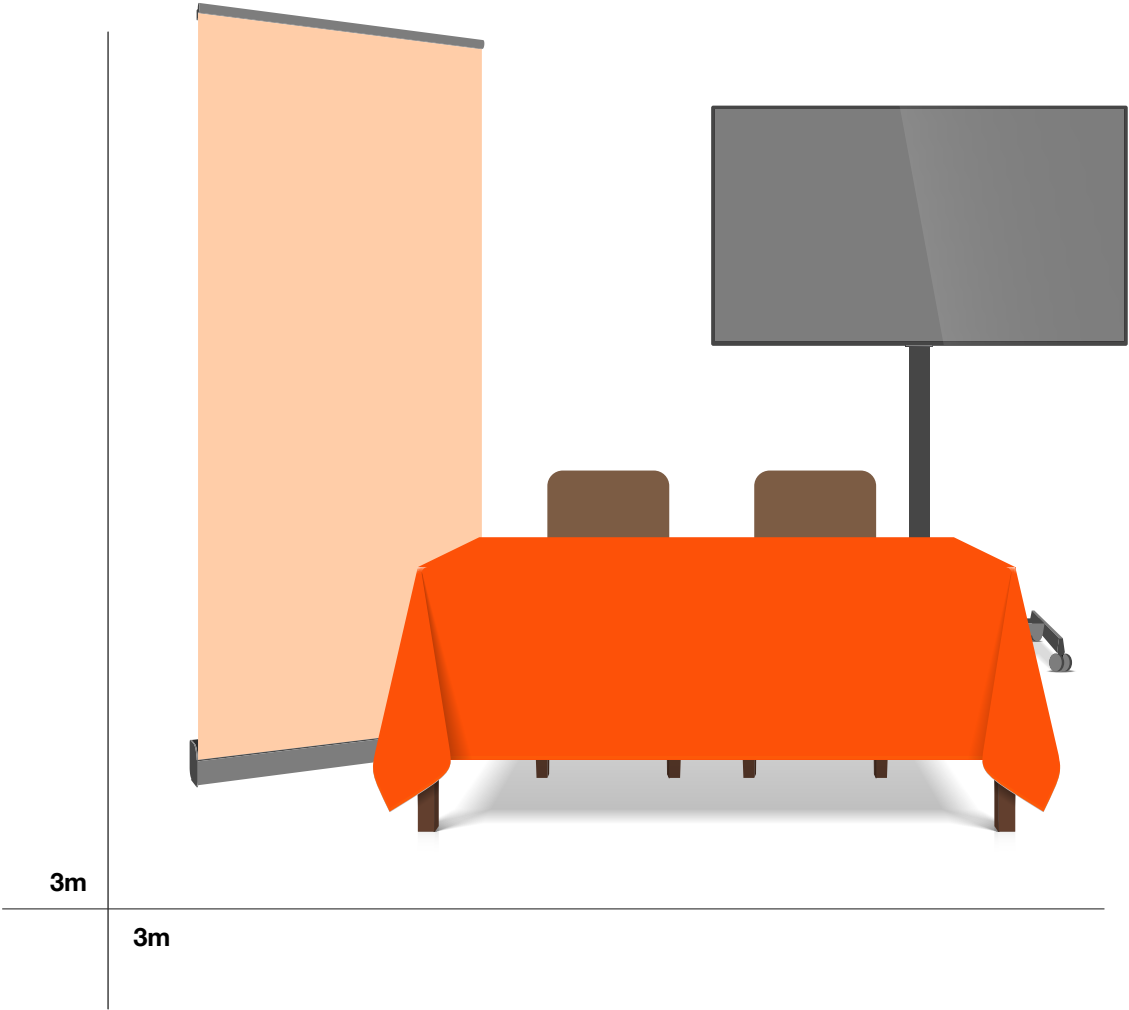
Cancellations of exhibitions must be done in writing and the following cancellation penalties apply:

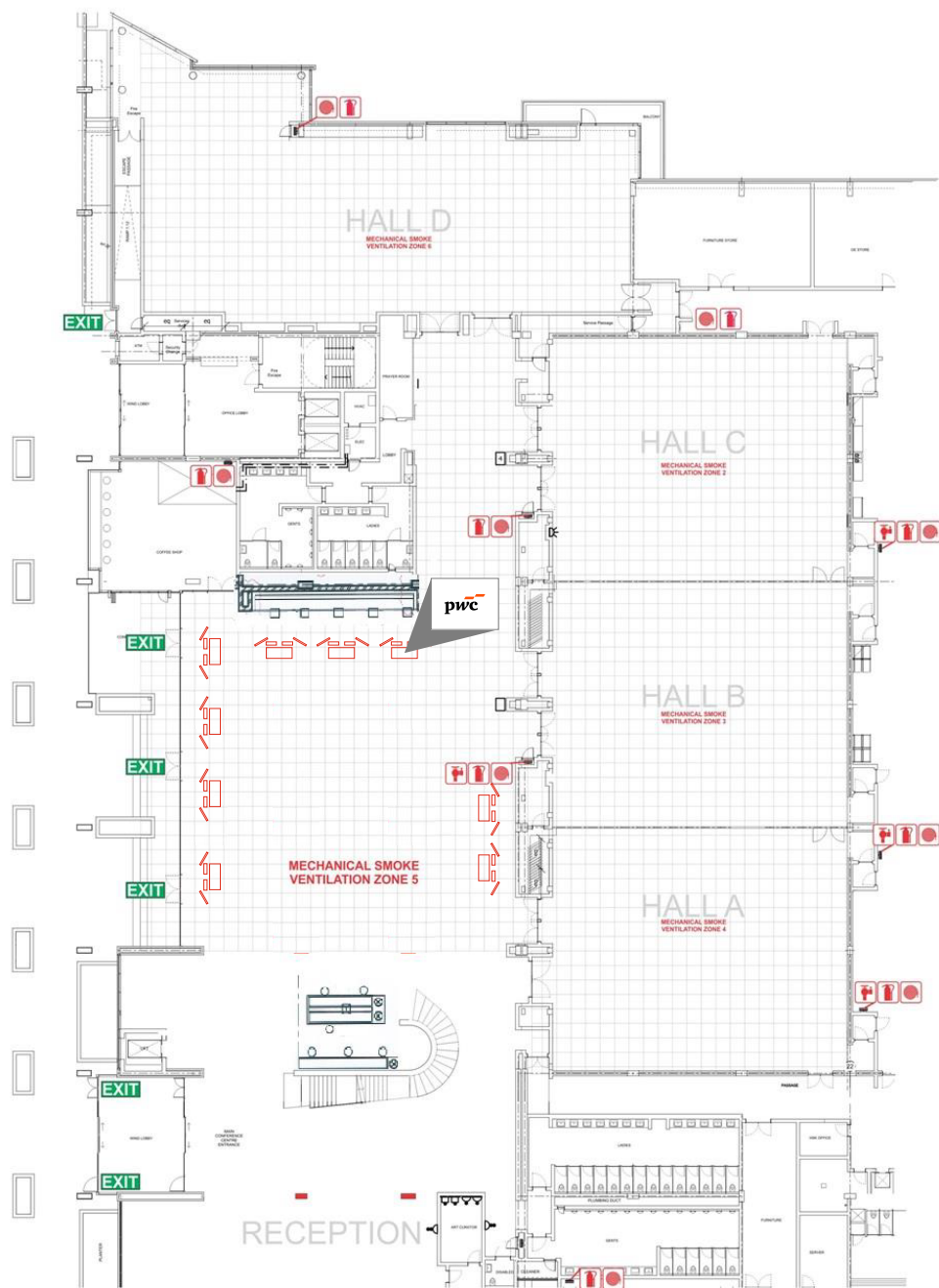


Floor plan
